Minutes

Sons of the American Revolution Miami Chapter BOD Meeting

January 14, 2019

Chapter President Bernard Wolff called the meeting to order at 7:01 P. M. with a wrap of the gavel..

Compatriot Rob Sileo recited the Invocation from the Chapter's Psalter.

President Wolff rendered the Pledge of Allegiance followed by 1st VP William Wicks, III who led us in the SAR Pledge.

Compatriot Popham, Sr. called for the roll call by introducing his Patriot Ancestor, followed by the rest of the attendees.

Chapter President Wolff reported that most of the preparations for the Annual Luncheon were finished. He will email a signed contract to the Embassy Suites by Hilton Miami International Airport. He also announced that the speaker for the event will be Thomas Jefferson (a.k.a. Compatriot John Stewart). Tickets are \$33.00 per person.

Compatriot Popham, Sr. announced that he had presented a Flag Certificate to Renee's Barbershop.

Secretary/Treasurer stated that on December 31, 2018 our bank account had \$2,618. We will be transferring \$10,000 from our investments to the bank account. We also sent \$4,425 in collected dues to the FLSSAR and NSSAR offices as of January 1, 2019. Additionally, the Chapter will order 30 medals and certificates to present to the 2019 ROTC/JROTC cadets. Popham, Sr. also mentioned that he had tickets so that the Ladies Auxiliary could conduct a 50/50 raffles at the Annual Luncheon.

President Wolff read the he Ladies Auxiliary Report. They have spent \$88.32 of the budgeted \$200.00 by providing coffee, assorted treats, cereal bars, sandwiches, and Danish rolls to the Miami VA Pathways. They are left with \$111.68 for the balance of 2019.

Registrar/Genealogist Rob Sileo reported that the Chapter gained 14 new members in 2018 and that we had 50 prospects as of this date.

Compatriot Wolff showed a print copy of a Cutler Bay communication that featured the presentation of awards to their mayor and Chief of Police.

General assent was given to President Wolff, 1st VP Wicks, and Secretary/Treasurer Popham, Sr. to represent the Chapter as delegates to the February 2, 2019 BOM being held in Kissimmee, FL.

President Wolff read a greeting card received from the President General Warren Alter.

Vignettes of History


Siege of Fort Charlotte

The Battle of Fort Charlotte or the Siege of Fort Charlotte was a two-week siege conducted by Spanish General Bernardo de Gálvez against the British fortifications guarding the port of Mobile (which was then in the British province of West Florida, and now in Alabama) during the Anglo-Spanish War of 1779-1783. Fort Charlotte was the last remaining British frontier post capable of threatening New Orleans in Spanish Louisiana. Its fall drove the British from the western reaches of West Florida and reduced the British military presence in West Florida to its capital, Pensacola.

Gálvez's army sailed from New Orleans aboard a small fleet of transports on January 28, 1780. On February 25, the Spaniards landed near Fort Charlotte. The outnumbered British garrison resisted stubbornly until Spanish bom-

bardment breached the walls. The garrison in vain for relief from Pensacola, but was the western shore of Mobile Bay and opened la.

tionary War in 1779, Bernardo de Gálvez, the mediately began offensive operations. In Septhe lower Mississippi River by capturing Fort

Bute and then shortly thereafter obtaining the surrender of the remaining British forces on the river following the Battle of Baton Rouge. Following these successes, he began planning operations against Mobile and Pensacola, the remaining British presence in the province of West Florida.
